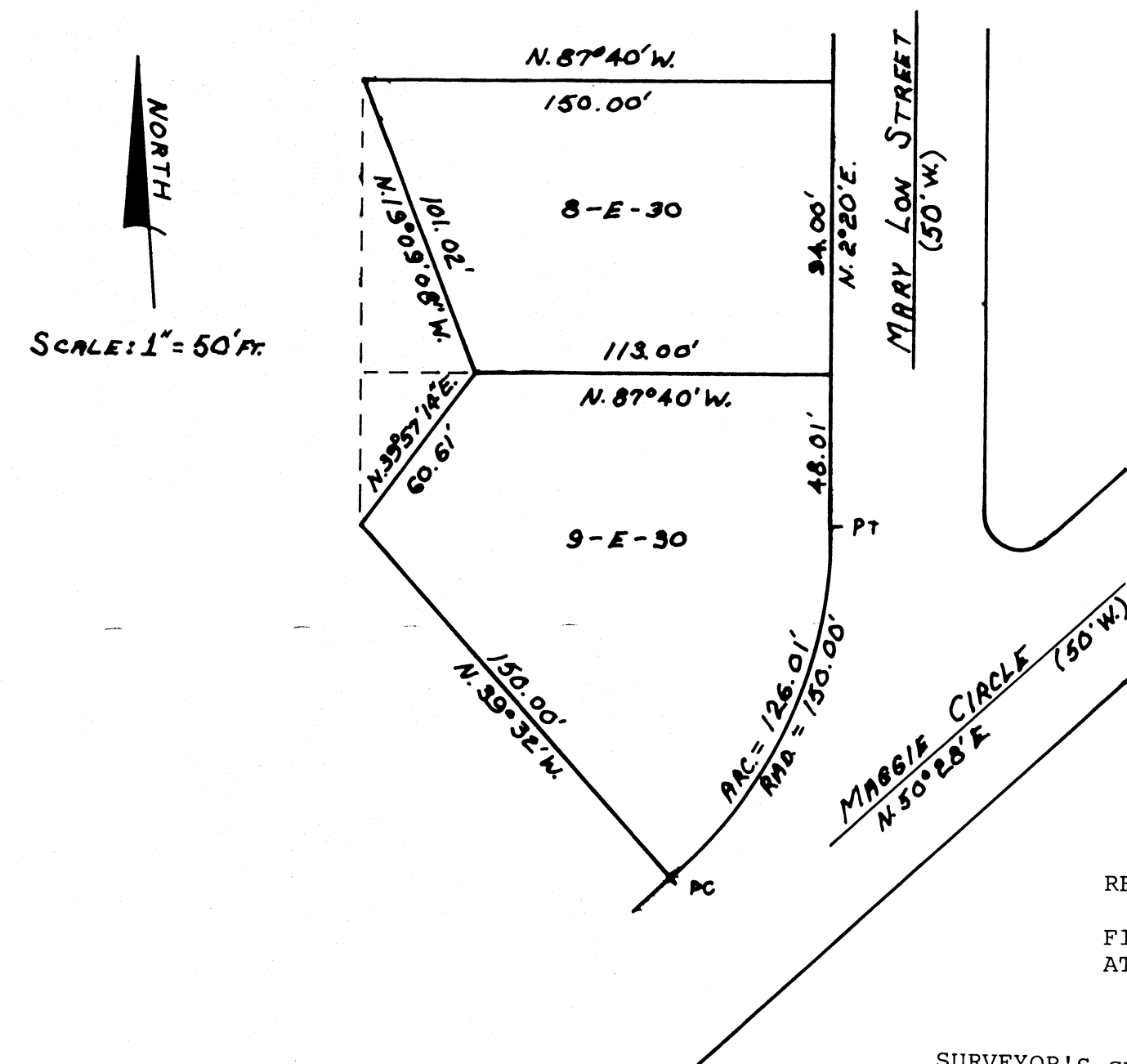

OWNER'S CERTIFICATE:

KNOW ALL MEN BY THESE PRESENTS, THE undersigned, TERRE DU LAC, INC., a corporation existing under the corporate laws of the State of Missouri, hereby certifies that it is the owner of the lands comprising the subdivision as shown upon this plat and mentioned in the Surveyor's Certificate hereto, and that it has had the same surveyed and the rear lot lines re-located in the manner as shown hereon. All property shown hereon shall be subject to any and all easements, exceptions, mineral rights and reservations, assessments, covenants and restrictions in existence and/or of record as of the date hereof, including, but not limited to those contained in the Declaration of Restrictions, Limitations, Uses, covenants, and Conditions dated July 31, 1980 and duly recorded in the land records of the Recorder of Deeds of St. Francois County, Missouri, in Book 743 at pages 300 through 309.

All streets and walkways shown upon this plat are hereby dedicated to and for the use of the Lot Owners.

A four foot (4') wide easement, two feet (2') on each side of all Lot lines, Street right of ways and Subdivision boundaries, is hereby reserved for the purpose of Land Surveys. Any obstructions to Instrument set-up or line of sight, on said lines, may be removed by a Registered Land Surveyor, or his agent, in the execution of a Survey which has been requested by the Owner of a Lot in this Subdivision.

A sixteen foot (16') wide easement along the back of each lot, eight feet (8') wide on common lines, and anchor easements as required, is hereby dedicated to Union Electric Company, and other utility companies, its successors and assigns to construct, reconstruct, use, operate, and maintain overhead and underground electric, communications facilities, and water and sewer utilities, with the right of ingress and egress to and over said easements, together with the right to trim or cut down or cause to be trimmed or cut down at any time any and all brush, saplings, trees, overhanging branches or other obstructions upon said easements and the premises adjoining same which interfere with the construction, maintenance or use of said underground and/or overhead facilities.
