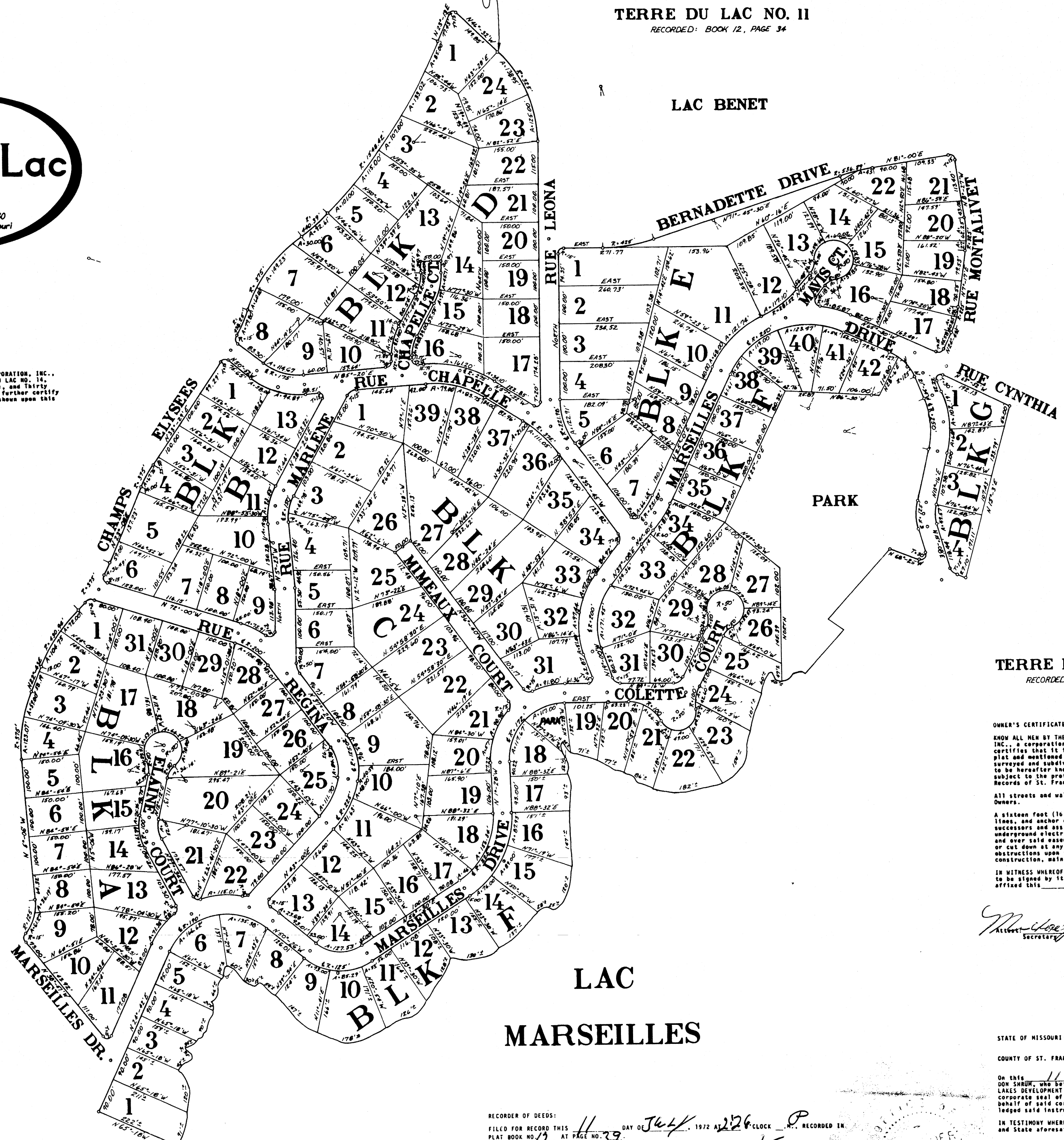

 KNOW ALL MEN BY THESE PRESENTS, The undersigned, BIG RIVER LAKES DEVELOPMENT CORPORATION, INC., a corporation existing under the corporate laws of the State of Missouri, hereby certifies that it is the owner of the lands comprising the subdivision as shown upon this plat and that it has had the same surveyed and subdivided in the manner as shown, which subdivision is hereby designated and subject to the protective covenants recorded in book No. 557 at page No. 157, Land Records of St. Francois County, Missouri.
